- (2) A copy of the valid business license of the Hotel

The hotel will display a certificate indicating its classification in a prominent place next to the reception desk.

The hotel will not present itself as a star classification which differs from the one determined for it in accordance with the regulation

I agree to an inspection being conducted for the purpose of determining the initial Hotel rating based upon the Hotel stars method as adjusted to Israel. Furthermore, the Hotel agrees to access rooms and public areas for the inspections according to the examiners requirements.
